Briefly describe your CERT experience

I have been involved with CERT since 1998. I have been with my current program since 2004. My background with CERT includes starting a program from scratch (1999) and inheriting a program (2004) that was only geared to business. I began leadership roles with CERT in 2007 in Orange County. I help develop a standard for CERT programs, CERT Instructor development and coordinator collaboration. In 2011, I applied and was selected to the EMI adjunct staff for CERT the train the trainer and program manager courses. I have served the state of CA in CERT program expansion, volunteer development and response capabilities. I have represented CERT training as an instructor trainer in numerous states (Alaska, Oklahoma, Rhode Island, Florida, Missouri and in CA) as well as internationally in China and Laos. I believe in the CERT program and its ability to help the individual personally prepare for an emergency as well as the program's connection to community in building resilience to recover.

Briefly describe a CERT project that you led or were a major part of and how it benefited your CERT program/community

In 2004, Orange County began its quest to expand the CERT program. There were 13 programs at the time and today there are 26. Our goal then and today is to continue to build programs, support leadership, expand training and build collaborative partnerships among all CERT programs including campus, teen, and workplace groups. When we began, we knew we needed to develop a strong relationship with city and county government so we worked to develop a strategy. This strategic planning and hard work gave us our CERT Mutual Aid Program (CMAP). We have a mutual aid agreement, activation and deployment plan, and advanced training modules to develop a volunteer program that could when called for expand to support the county's needs for volunteer needs. We have utilized the CMAP plan and volunteers for wildfires, flooding and most recently at points of dispensing (vaccine and testing site support). This dedicated group of CERT coordinators meet monthly, share training opportunities including approved state train the trainer courses, grant funds/equipment and support the county's mission to improve volunteer coordination. I have served as its chair three times and hold the position currently for 2021. Our county received national recognition and an award in 2015 as a "best practice" in CERT program development by FEMA.

As a practicing CERT Program Manager, I have the benefit of being part of the program on a daily basis. As the current chair of the Orange County CERT Mutual Aid program we meet monthly. We create and provide a formal agenda and follow up with minutes stored in the county's portal for review and historical purposes. We phone, email and text as we created a master list of coordinators and alternates. We exercise our ability to activate twice annually. CMAP is represented at Orange County emergency management meetings monthly and reports in writing/verbally are completed monthly as well as an annual report due to grantors and County OEM.

In the state of CA, our CERT program liaison shares reports and information. These reports are shared via all programs in the county. I also share this information with all instructor training master lists (beginning in 2007). I also share NCA communications with OC program and these lists that include instructors from all over the country.

My goal for NCA communications would be to connect with programs consistently and share valuable NCA information. I would drive people to the NCA website for additional information and encourage participation and sharing of expertise in NCA committees, conferences and special projects.
