



#### North Carolina Cases – March 25, 2020










#### North Carolina Cases – March 29, 2020









#### **Precautions**

- Social Distancing (>6 feet apart)
- Body hygiene
- Home/workplace hygiene
  - Disinfect heavily-used areas
  - Wash clothes







#### Wake County Stay-at-Home Order

#### What's not allowed:

- Started Friday, March 27 @ 1700
- No gatherings of any size
- Non-essential businesses must close
- Public transportation should be used only if necessary







#### Wake County Stay-at-Home Order

#### What is allowed:

- Shopping for food, take-out orders, and drive-thru
- Operating businesses that provide critical services (hospitals, banks, etc)
- Caring for a family member or pet in another household
- Providing childcare for parents whose jobs are considered essential
- Utilizing plumbers, electricians, and others who help maintain the safety and sanitation of residences
- Visiting a local park, greenway, preserve (but maintain social distance!)

#### **Know Three Things**

#### Your Home

- Utilities
- Where to seek shelter
- Sheltering in place
- Your Neighborhood
  - Who are my neighbors, and what is their contact info?
  - What hazards could we commonly face?
  - What roads can I take if I have to evacuate?

#### Your Town

- Where are the first responders?
- Where are the hospitals and urgent care facilities?
- How do I get the right information in an emergency?







## Answering the Call







## Answering the Call

- Emergencies don't come sequentially
- We may not get called for the pandemic, but...
- We could get called for something else DURING the pandemic





#### Answering the Call...

- 1. Apex Fire Department initiates the call
- 2. You and your family come first
- 3. If you show any signs or believe you may have been exposed, stay home!
  - Report back with your condition
  - 2. Monitor for 14 days
- 4. Acknowledge the call, follow instructions







#### En Route...

- Assembly point will be identified when mobilized
- 2. Keep your Apex CERT ID badge with you
- 3. Bring your CERT bag (particularly your PPE)
- 4. Follow local law enforcement instructions
  - 1. Identify yourself as a CERT member
  - 2. Report any issues back to us







#### While on Duty

- 1. Maintain social distancing
- 2. Have PPE ready
- 3. Be polite to the public, but...
- 4. Answer questions with minimal information
  - 1. "We're just here to help Apex Fire Department"
- 5. Avoid talking to media







#### **Handling Patients**

- Assess patients for COVID-19 symptoms from 6+ feet away
- Properly wear your PPE before approaching patient
  - Nitrile gloves
  - N95 mask
  - Protective goggles (eyeglasses/sunglasses/contacts do not count)
- Minimize contact with patient until facemask is on the patient
  - This is for source control
- Avoid touching your face







#### Handling Patients (Cont'd...)

- Report suspected cases prior to other agencies' arrival (EMS, police, etc.)
- Keep family members separated as much as possible
- Document care after cleaned up
  - Document level of contact between your team and the patient





#### What to Ask Patients?

- 1. Have you traveled outside of the country in the last 14 days?
- 2. Have you had any fever in the last few days or 2 weeks?
- 3. Have you had any lower respiratory issues or pain? Trouble breathing (not from pollen or head congestion)?
- 4. Have you had any contact or possible contact with anybody with the known virus?
- 5. Have you had any flu like symptoms over the last few weeks?







#### **Between Patients**

- Change gloves frequently
- If you can't change gloves, sanitize them using bleach
- Before entering transportation/CERT gathering area
  - Remove PPE
  - Practice hand hygiene
- Dispose of used PPE properly







#### Meanwhile, Back at the Base...

- Keep it clean!
- Don't wear PPE from the field in the base
- Wipe down commonly-used surfaces
  - Tables, chairs, doorknobs, etc.
  - Radios, electronic equipment need special care
- Wash hands frequently
